Several questions are prefaced by some relevant information. In some cases this may cause you to rethink previous answers. However, it is vital that you do not alter your initial answers in the light of any background information presented with later questions. The order of the questions has been carefully chosen to avoid any bias that could be caused in this way.

Attitudes to animal management

18. All of our larger wild animals (deer, thar, chamois, goats, pigs) have changed our native forests and grasslands and also compete with some native wildlife for food. Introduced predators (cats, ferrets, stoats, weasels, rats) directly kill many native species, particularly birds. Rabbits and hares are agricultural pests and compete with farm stock for pasture. Possums are both agricultural pests (by contributing to the spread of the disease bovine tuberculosis) and conservation pests (because of the damage they cause to native forests and competition with native wildlife for food). Wasps compete with native wildlife (insects and birds) for food and also make it unpleasant for the public to use many forests and other recreation areas, particularly during the summer months. Given that there is a limited amount of money available for research and control, where do you think the effort and expenditure should go? Rank the following animals in order of priority. (*give each box a different number from 1 to 4; use "1" for the most important, "2" for the second most important, etc.; if you consider that no action is required, use a dash, "-", in the relevant box*)
