- ORCID can be integrated in all system, independent on platform, subject, institution...
- ORCID can act as an identifiers hub.

Integrating ORCID in publishing systems is a lot of work

- Use an ORCID enabled system
 - [Open Journal System](#) (OJS) (sign-in and export)
 - [Janeway](#) (sign-in)
- Read the [ORCID API](#) Documentation
- Join the [API User Group](#) for community support
- Get direct support from the ORCID team (for [members](#))

Connecting ORCID iDs to article submissions is a good thing, but generates more work for authors

- ORCID authentication allows automatic metadata population.
- There are workflows for [publishing systems](#).
- Authors can benefit from Auto-update.

ORCID is a commercial US organization

- ORCID is non-profit and has a sustainable community-driven support model.
- ORCID has members in over 45 countries.
- Its staff is based in 16 different countries and time zones, speaks 15 languages.

ORCID can only be implemented by big publishers

- ORCID is a neutral organization
- ORCID is supported by open source publishing systems.
- Small journals can also be direct members (e.g. [Botswana Journal of Agriculture and Applied Science](#), [Pan African Medical Journal](#), etc.)
- The [Publisher Open Letter](#) is signed by a wide range of journals and publishers

An integration with ORCID is only possible with a membership

- Use the [public API](#) for authentication and collection of the main descriptive metadata (author's name and affiliation).
 - Publishing systems such as OJS offer workflows for both public and member API.

It's only possible to connect journal articles to an ORCID record

- Many further different [work types](#) are supported (e.g. book, book-chapter, working-paper, preprint, data-set, software, etc.)
- The C stands for “contributor” → use [CRedIT](#) contribution roles

“Peer review activities aren’t integrated in ORCID”



Peer review is not integrated in ORCID

- We DO support peer review.
 - Publishers can add peer review activities directly ([workflow](#)).
 - Authors can export verified peer review activities using Publons ([workflow](#)).
- Active participation in the [Peer Review Week](#)



“ORCID identifies only corresponding authors”



ORCID identifies only corresponding authors

- Several publishers are implementing workflows to collect authenticated ORCID iDs from co-authors (e.g. F1000).
- Several publishing systems (e.g. OJS, Editorial Manager, etc.) provide workflows to collect these iDs.

ORCID iDs and DOIs are good stuff but they aren't interconnected

- Discover the magic of auto-update (available for Crossref and DataCite DOIs).
- Crossref and DataCite metadata search offer the export to ORCID Records.

“ORCID is suitable for Science, Technology, Engineering and Mathematics publishers but not for Humanities, Arts and Social Sciences”



ORCID is suitable for STEM publishers but not for HASS

- ORCID supports identification across knowledge areas.
 - ORCID is integrated in the Open Library of Humanities ([OLH](#)).
 - [heiJOURNALS](#) (Journal platform of the University of Heidelberg) hosts journals of linguistics, library science, ethnology, philosophy...
