In shipment are five copies each of the status report and recovery plan for <u>Gaura neomexicana</u> ssp. <u>coloradensis</u> (Colorado butterfly plant) as called for by Agreement No. 14-16-0006-84-955(R) between the US Fish and Wildlife Service (USFWS), the Air Force Regional Civil Engineer for Ballistic Missile Support, and F. CHANGES AND ADDITIONS TO THE STATUS REPORT, AND RESPONSES TO COMMENTS BY THE US FISH AND WILDLIFE SERVICE:

Section

- I.2.B.1.b. The Nature Conservancy (TNC) Heritage ranking system is explained.
- I.3.A. A non-technical description of Colorado butterfly plant has been added.
- I.3.B. A discussion of local field characters not found in the literature prior to this study has been added.
- I.5.B.2. Areas covered during the 1984-1986 inventory are explained more clearly (see also III.16.E. and Appendix VII).
- I.7.B. Colorado populations have been added.
- I.7.D.6. <u>Gaura neomexicana ssp. coloradensis</u> population numbers on Warren Air Force Base (WAFB) prior to the 1986 Base inventory were discovered to be only estimates. There are no population trend data available other than those from monitoring site plots.
- I.7.D.7. The apparent decrease in <u>Gaura neomexicana</u> ssp. <u>coloradensis</u> populations on WAFB is discussed.
- I.7.E. The apparent decrease in <u>Gaura neomexicana</u> ssp. <u>coloradensis</u> populations on WAFB, and the possible influence of community succession are discussed.
- I.9.A.-D. Information on land use on WAFB has been updated.
- I.10.A. The detrimental effect of overgrazing on <u>Gaura neomexicana</u> ssp. <u>coloradensis</u> habitat is explained in more detail.
- I.10.B. Water development as a potential threat has been explained in greater detail.
- II.11. The apparent decrease in <u>Gaura neomexicana</u> ssp. <u>coloradensis</u> populations on WAFB, and the WAFB Management Plan are mentioned.
- II.12.A. Reasons for the Rocky Mountain Heritage Task Force (RMHTF) recommendation to the US Fish and Wildlife Service (USFWS) concerning listing of <u>Gaura neomexicana</u> ssp. <u>coloradensis</u> are presented. Included are possible channels for Endangered Species Act protection on private land.
- II.13.A. "Critical habitat boundaries" has been changed to "Critical habitat boundaries, as understood at this time," to point out that more biological data are needed before precise critical habitat boundaries can be established.

- II.14.B. The need for continued monitoring on WAFB is mentioned.
- II.15. A few additions to the list of Interested Parties have been made.
- III.16.C. The specimen marked by the USFWS as "not on map" is part of Occurrence No. 17, a map of which is included in Appendix I.
- III.16.E. Recent fieldwork is explained in more detail.


Appendix III. Recommended Conservation Sites
