**PREAMBLE**

This exam equivalent assignment reports on the Individual Education Plan (IEP) which you have worked on for a school learner. During the year, you identified a learner who is experiencing barriers to learning or special educational needs. The learner may have difficulty with some aspect of language, reading, writing, spelling or maths. There might be physical, genetic, sensory, cognitive or neurological impairments present. You obtained written consent from the parent or guardian to work with the learner. Include this information in an appendix of the assignment. You then conducted a diagnostic scholastic assessment to ascertain the learner's competencies and you have written an educational support needs report. You then designed an Individual Education Plan and conducted a practical remedial programme. For this final exam equivalent assignment you will report on the work done during the year. Remember to respect the confidentiality of the learner and use a pseudonym when you refer to the learner in this assignment.

**PART A: DESIGNING THE IEP AND PRACTICAL WORK:**

You conducted at least six (6) hours of practical learning support or remedial work with the learner. In your practical work supporting the learner, you covered all scholastic areas - language, reading, writing, spelling and mathematics.

Fill in the IEP form that is as adapted from the Department of Basic Education - SIAS, 2014. Keep the information concise and accurate. Base the IEP on the SNA you have previously completed for the learner. Attach the SNA or formal assessment report as an appendix to this assignment. The examiner will consider the appropriateness of the IEP against the SNA done for this learner.

**PART B: NARRATIVE REPORT DESCRIBING THE CASE:**

Write a narrative paper describing and discussing the learner's case in detail.

Write a personal reflection on your process of designing and implementing this IEP. Reflect on what you have personally learnt from this process. What worked well? What would you do differently next time? What skills and knowledge have you gained? Include feedback received from the teachers and parents regarding the process of collaboration in designing and implementing the IEP.
